# Rescheduled annual meeting

he Red Lake Electric board of directors has made the decision to hold the cooperative's 82<sup>nd</sup> annual meeting on Wednesday, Oct. 28, at 10:30 a.m. The meeting will be held at the American Legion in Red Lake Falls, Minn. Our annual meeting was originally scheduled for March 25, but was postponed due to the COVID-19 restrictions. This annual meeting will be different than past years. Planning is challenging due to the constant changes and restrictions of the pandemic.

The annual meeting will be held to conduct essential business only and will NOT include a meal, prize drawings or entertainment. We hope these will return for next year's meeting. There will be a shortened agenda consisting of an approval of last year's minutes, a brief financial report and general comments about our operations. We are asking our members to preregister by calling our office, 218-253-2168, to monitor the attendance. If you feel ill or suffer from an underlying health condition, we ask you to please refrain from attending. We will continue to be diligent about COVID-19 restrictions and guidelines, which include social distancing and the need to wear a mask. We expect this condensed meeting will greatly reduce attendance but allow the cooperative to meet its bylaw requirements. We trust our membership will understand that the altered meeting and that precautions being taken are to best protect the safety and health of our employees, members and the general public.

#### Make your voice heard

## **Member Service Department**

ven though I work in the energy industry, I – like most people – still don't think much about the electricity I use. I expect the lights to turn on when I flip the switch and the coffeemaker to work each morning. Because electricity is so abundant, we don't think much about it. Since many of us have been spending more time at home during the past few months, we have likely been using more energy. And yet, we still expect an endless supply of power with uninterrupted service 24/7. The only time we really think about electricity is when the power goes out or perhaps when the monthly bill arrives.

Given how electricity powers our modern lifestyle every day, it's a great value, especially when compared to other common services and expenses. For example, think back to the cost of a gallon of gasoline 20 years ago. Consider the cost of groceries or a cup of your favorite specialty coffee from a few years back. In comparison, the cost of electricity has remained largely flat, unlike most other consumer goods.

Like many of you, I have a cellphone to stay connected, and I subscribe to cable, Netflix, Disney+ and Amazon Prime Video so I can enjoy viewing options. #### AMI update

We are on the tail end of deploying the new AMI metering system and hope to be fully complete in the first quarter of 2021. We have all the main meters deployed; we are just working on the off-peak meters, so watch your mailboxes for a letter coming (21801 Richard Kezar) from me if your off-peak meter still needs to be replaced. We are concentrating on the off-peak meters that are tied to the Oklee substation. Minnkota Power Cooperative is doing a substation rebuild so the "old" meter reading equipment will not be included on the rebuild.

#### Apple Fritter Bread

1/3 cup brown sugar 2 teaspoons ground cinnamon, divided 2 Granny Smith apples, peeled and chopped ½ cup butter, room temperature ⅔ cup granulated sugar 2 eggs 1½ teaspoons pure vanilla extract 1½ cups all-purpose flour 1¾ teaspoons baking soda ½ cup + 1 tablespoon milk, divided ½ cup powdered sugar

Preheat oven to 350 degrees. Spray a 9-by-5-inch loaf pan. Set aside.

In a small bowl, combine brown sugar with 1 teaspoon cinnamon.

In another bowl, combine the diced apples with the remaining 1 teaspoon of cinnamon and stir to mix. Set aside.

In a large bowl, cream together the butter and granulated sugar. Beat eggs in one at a time until completely mixed. Add vanilla extract and mix.

In a medium bowl, whisk together the flour and baking soda. Add the ½ cup of milk and mix until smooth. Add the flour and baking soda mix to the butter mixture and stir until well-blended.

Pour half of the batter into the prepared loaf pan. Layer half of the apple mixture on top of the batter, followed by half of the brown sugar mixture. Gently press (31515 Cole Audette) the apples into the batter.

Add the remaining batter to the pan, followed by the remaining apples and brown sugar mixture. Lightly press the apples into the batter and swirl the brown sugar between the apple chunks and into the batter.

Bake for 50 to 60 minutes or until a toothpick inserted in the center comes out clean. Allow to cool for 15 minutes on a wire rack before removing from the pan.

While the bread cools, prepare the glaze. In a small bowl, combine the powdered sugar with the remaining 1 tablespoon of milk. Mix until smooth and then drizzle over the cooled bread.

# Four ways to be Cyber safe

We all know the internet can be dangerous and scary. Experts warn of a triple threat these days. First, scammers are taking advantage of COVID-19 uncertainty, from offering phony cures and tests to promises of financial assistance. Second, with more people working from home due to social distancing, there may be fewer office-based security measures in place. Third, the FBI warns that increased use of mobile banking offers more chances for cybercrime. So, here are four cybersecurity tips to keep you safe:

#### **Use strong passwords**

And change them regularly – many sites and apps make that easy to do by clicking on the "forgot your password" link. The best passwords are at least eight characters and include different types of characters – try using a memorable verse from your favorite song and adding a few numbers and special characters (\$!\_&), or even a space. If you are like most people, remembering all your passwords is a challenge.

Choose a security option based on the value of what you're protecting. The options you use to secure your bank and retirement account passwords might be different than how you store your social media passwords.

Password apps keep them in one place and may be a great option for some passwords, but you can be in big trouble if you forget the password that lets you into that app. Keeping passwords on paper or in a notebook might be more secure than using the same password for everything, depending on how secure and hidden that paper is from other people at the office or kids at home.

#### **Install software updates**

Your apps and operating systems will periodically send updates. Install them – they often include protections against the latest security threats. But remember, those updates come from the apps and not from emails or social media notices. An email containing an update may be a scam – instead of clicking on the link, go to the app's website to see if there really are updates available.

# Use two-factor authentication

That phrase is just a fancy word for a technique that adds an extra layer of security in addition to a password. Banks increasingly use this system – when you try to con-

nect with them, the bank may text a code number to your phone that you type in to complete the sign-in process for your account.

Keep in mind that answering a security question is similar to having a password – both are something you know. Answering a security question won't provide the same level of additional security as that of a second factor. A second factor will be something you have, like your phone to receive a passcode, or something you are, like a biometric fingerprint, in addition to something you know, like a password or security question.

#### Think before you click

Be wary of any offer or link that comes through the internet, whether by email or social media, or even a phone call instructing you to get online. Don't click on a link unless you know for certain what it is. Ideally, you should be expecting to receive the link. Even emails from friends should be suspect – hackers can impersonate someone you know to send a link or an attachment, and either can result in you downloading malware that can take control of your computer in ways you may not even be able to detect.

If you have any doubt, whether it's a link to a software update or an attachment (27694 Robert Merrill) to a funny cat video, give the sender a phone call to find out if they really sent it or if it's a scam.



## Need help to pay your electric bill? Help is only a phone call away!

ed Lake Electric is prepared to work with members who are in need of assistance paying their electric bills. For more information about the Cold Weather Rule, call Red Lake Electric Cooperative or see MN Statutes, Chapter 216B, which governs disconnection policies of residential heating sources from Oct. 15 through April 15. Here are some common questions:

#### Can my heat be shut off in the winter?

**YES**, unless you take steps under the Cold Weather Rule (CWR) to protect yourself. You must contact Red Lake Electric Cooperative to apply for protection from having your heat shut off. This is true for all residential customers.

#### FEDERAL/STATE **ENERGY ASSISTANCE**

If you need help paying your electric utility bill, you may qualify for state or federal fuel assistance. For complete qualification and application information, contact your local county welfare or community/citizen's action council listed below. These organizations may also provide budget counseling.

including senior citizens and families with young children.

#### Will you disconnect me without my knowledge?

No. RLEC will give you a "Disconnection Notice" on your electric bill. This will state the amount you need to pay as well as the date by which you must contact RLEC to avoid disconnection. If you do not contact us by the disconnection date, we will make a courtesy phone call reminding you to make your payment.

#### How can I keep my heat on or get reconnected if I am already shut off?

You must make and keep a payment plan with Red Lake Electric Cooperative. The payments don't have to be the same amount each month. RLEC will work with you to make suitable arrangements to help you keep your electricity. Once arrangements are made, you must contact Red Lake Electric Cooperative if you are unable to (22823 Dean Bruggeman) make a payment or your service may be shut off.

#### When I contact RLEC to apply for the CWR, what happens?

- You will make a CWR payment plan, which you must keep to be protected.
- If you and the utility cannot agree on a payment plan, you have 10 days to appeal to the Public Utilities Commis-
- The Commission will help you set up a payment plan.
- Your service will stay on during the appeal process.

#### What happens if I can't make my payments as planned?

If you can't make your payments, call RLEC immediately to make a new CWR

payment plan. If you do not make your payments, your service may be shut off.

#### What if I need help reading or understanding notices from my utility?

- The CWR has a "Third-Party Notice"
- If you would like help applying for the CWR, you may arrange for another person to get a copy of any disconnection notices or other important information at the same time you receive it. This may be a friend, family member or anyone who is willing to help you understand the notices or set up a CWR payment plan. This person is not responsible for paying your bill. They are only agreeing to help you understand notices from Red Lake Electric Cooperative.

#### How do I sign up for Third-Party Notices?

Call Red Lake Electric for a sign-up form. The form must be filled out and signed by (20983 Hilmar J. Ellingsen) both you and the person you want to be notified and mailed back to the utility.

#### Are military personnel subject to a shutoff?

Minnesota law protects a residential customer if a member of the household has been issued orders into active duty, for deployment or a change in duty station if they are unable to pay their electric bill. You must call Red Lake Electric to set up a payment plan. For more information see MN Statutes, Chapter 325E.028 (Utility Payment Arrangements for Military Personnel).

## **ELECTRICAL SAFETY TIPS FOR HUNTERS**

This hunting season, we encourage all members to be aware of electrical equipment and take necessary precautions while hunting. Keep these safety tips in mind as you enjoy the great outdoors.

- ▶ Take notice of posted warning signs and keep clear of electric equipment.
- Do not shoot at or near power lines or insulators.
- ▶ Know where power lines and equipment are located on the land where you hunt.
- ▶ Be especially careful in wooded areas where power lines may not be as visible.
- ▶ Do not place deer stands on utility poles or climb poles. Energized lines and equipment can conduct electricity to anyone who comes in contact with them, causing shock or electrocution.
- ▶ Do not place decoys on power lines or other utility equipment. Any nonelectrical equipment attached to a pole can pose an obstruction and serious hazards to our line crews.



It's hard to believe winter is right around the corner. Since weather conditions and future wholesale power market prices make the amount of load control hours hard to predict, all of our off-peak members are encouraged to have a reliable, automatic dual heating system in place and ready to use.

To ensure your total comfort this winter, consider the following questions (24757 Denise Ness) about your backup heating system:

- 1. Is the system sized to heat your entire home or business?
- 2. Does it maintain an adequate comfort level?
- 3. Is it reliable?
- 4. Is it fully automatic?

Check current fuel prices and be sure to fill your propane or fuel oil tank at the beginning of the season. Also, make sure your tank is large enough to hold an adequate supply. Remember, prices typically rise as demand increases during the heating season.

Our member services department is glad to answer any off-peak questions you may have.
